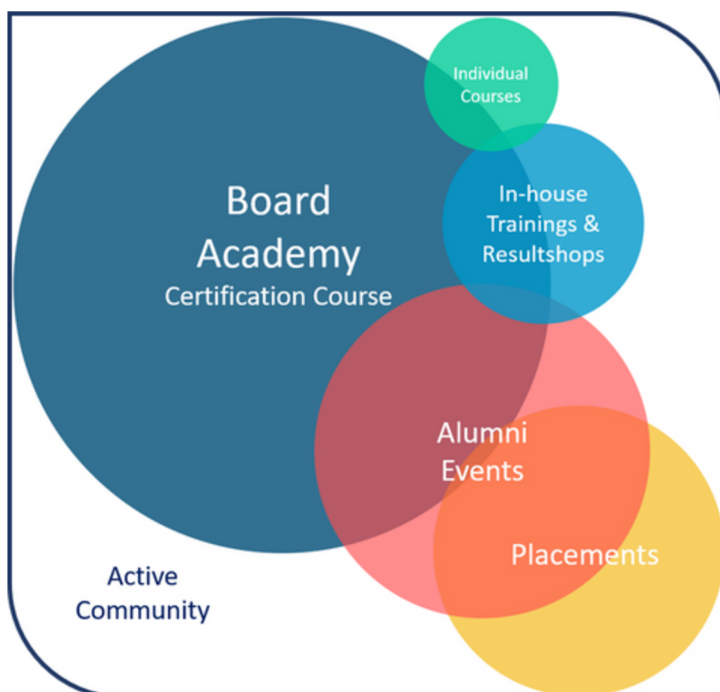

Concept

- Six modules per course spread over half a year

Schedule

- One module per month
- Start: Thursdays at 6 p.m., end: Saturdays at 4 p.m.
- 5 modules in Munich, 1 module in Frankfurt
- The courses take place at the offices of the partner of excellence
- Access to the learning platform XU
- Detailed exam preparation after the modules
- Final exam at the end of the course

Certification

Upon passing the final exam, you will receive the certificate "Certified Member of the Supervisory Board/Advisory Board", which is valid indefinitely and signed by all partners of excellence. Two masterclasses are also included, which will certify you as a "Sustainability Executive" and "AI Executive" upon passing.

Investment

The participation fee is € 11,800 plus VAT. Catering during the modules and dinner with our dialogue partners are included, as are the annual license for the learning platform XU and certification.
